Sub:- Affiliated Colleges – Grant of extension of provisional affiliation to Omega P.G.College-MBA, Edulabad (V), Ghatkesar(M), Ranga Reddy District to offer **MBA Course** for the academic year **2018-2019** – Orders – Issued.

Based on the approval of the AICTE and on the recommendations of the University Inspection Committee, sanction is hereby accorded for grant of extension of provisional affiliation to Omega P.G.College-MBA, Edulabad (V), Ghatkesar(M), Ranga Reddy District to offer **MBA Course** with an intake of **(180)** for the academic year **2018-2019**.

The above extension of provisional affiliation orders is sanctioned, subject to fulfillment of the conditions / deficiencies pointed out by the University Inspection Committee, AICTE, Government of Telangana and general rules of affiliation.

The College has to ensure that the faculty student ratio and faculty cadre ratio of Professors, Associate Professors and Assistant Professors is maintained by appointing as per AICTE/OU norms for an sanctioned intake of students at any time. All the requirements shall be as per AICTE process hand book for the year 2018-2019.

1. Prescribed books of 500 volumes to be procured for the year 2018-2019.
2. Two International journals and Ten National Journals to be subscribed for the year 2018-2019.
3. Five Computers with internet facility to be provided in the Library.
4. Teaching Diaries and Students attendance registers to be maintained properly.
5. Salaries to be paid through Account Payee Cheques/Bank only.
6. Three Governing Body Meetings associating University nominee to be conducted in a year.
7. The Faculty to be deputed for Refresher Courses/Orientation Programmes/Faculty Development Programmes conducted by Osmania University/Other Institutions.

NOTE: As per the sanctioned intake the College has to appoint one Principal, required number of Professors, Associate Professors and Assistant Professors. As such, if any short fall in the above cadre, the college has to recruit them immediately through a duly constituted selection committee as per AICTE (as per AICTE process hand book for the year 2018-2019) and OU norms. Surprise Inspection may be conducted by the University at any time.

Further, the conditions / deficiencies pointed out by the University Inspection Committee:

- 1.Salaries to be paid through Account Payee Cheques/Bank only.
- 2.Prescribed books worth Rs.75,000/- to be procured.
- 3.Three International and Six National Journals to be subscribed. The college is also advised to go for e-journals.

You are, therefore, directed to submit the compliance report on the fulfillment of the above deficiencies/conditions in the following format along with the documentary evidence **within one month** from the date of issue of this order, through the University representative on the Governing Body of the College.
